Admission Agreement

1. Pupils at The King's School, Tynemouth are subject to the rules of the school concerning attendance, dress, sport, conduct in and out of school and on all matters upon which the Headmaster and the School Governors may make regulations. All pupils have an obligation, if required by the school, to take part in school sports and other out-of-school activities, and to attend practices, meetings etc on school days and at weekends.
2. When we offer a firm place to a pupil, an Entrance Fee of £50 is payable on acceptance of the offer. This fee is not returnable. A Registration Fee is not charged.
3. Parents who, after accepting a place at the school, withdraw the acceptance within one month of the first day of term, are liable for that term's fees.
4. School fees are payable in advance on the first day of the term to which they relate, or by Direct Debit over a ten-month period. There is no refund of fees if a pupil is absent from school.
5. A term's notice in writing to the Headmaster, or a term's fees in lieu thereof, is required before the removal of a pupil, except in special circumstances of which the Governors will be the sole judge.
6. In exceptional circumstances, it may be necessary for the Governors to require a pupil to leave if in their opinion it is in the best interests of the pupil and/or the school. In such a case no refund of fees will be made.
7. Consent is given to the school making use of photographic images of pupils and/or teams in the promotion of an event in any local, regional and national media, in school publications and on the school's website (however, the school will not publish photographs of individual pupils with their names on the website), and for fundraising, marketing or promotional purposes and to maintain relationships with former pupils of the school.
